- Four Outcome Goals
- Discovery, Learning, and Research Infrastructure: evaluated by AC/GPA
- Stewardship: monitored within NSF
  - "Support excellence in science and engineering research and education through a capable and responsive organization."

## **FY 2007 Stewardship Results**

- Achieved 7.5 out of 8 goals
- Did not achieve: the cost and schedule measure under Management of Large Facilities
- NSF achieved the Stewardship Goal because a majority of measures & milestones were achieved

# **Changes in FY 2008**

- No changes in wording of each goal / performance area
- Change in nomenclature: from Stewardship "goals" to Stewardship "performance areas"
- Measures and milestones were added or updated, based on what we learned in FY 2007 and on new priorities for FY 2008
  - See background information for details

#### **Examples of New Measures/Milestones**

- Institute mandatory training for NSF staff on merit review
- Develop a searchable database of NSF proposal reviewers
- Create a standard orientation module for panels with information on implicit bias
- Conduct further analysis of data on the impact of proposals and award mechanisms & potentially transformative research
- Conduct a BSR at least once per 5-yr award cycle

## **Progress in FY 2008**

- Monitored by the Foundation-wide GPRA Working Group
- Quarterly reports on available goal results are submitted to NSF Senior Management.
- Each performance area has an NSF lead program officer or organization responsible for implementation.

## The Future of Stewardship

- Revise and update the performance areas for FY 2009 and beyond
- Maintain a balance of qualitative milestones and quantitative measures
- Revisit the Stewardship goal during the Strategic Plan update midway through the FY 2006 – 2011 period
